

RWA SERVICE CONTRACT

This Service Contract is executed on this **01st December 2025** between

North East Health Care Private Limited, having its office/place of business at Golf Course Ext Road, Sushant Lok 2, Sector - 56, Gurugram, Haryana-122011 and Registered Office at Plot No 67/1; Opposite Panchamrut Bunglows Near Shukan Mall; Off Science City Road; Sola ; Ahmedabad; Gujarat; 380060; India. hereinafter referred to as "Marengo Asia Hospitals Gurugram" or Hospital , (which expression shall unless repugnant to the context or contrary to the meaning thereof be deemed to mean and include its successors in business and permitted assigns/ partners for the time being and the survivor or survivors of them) party of the First Part

AND

"SLERWA" hereinafter referred to as "RWA" (which expression shall unless repugnant to the context or contrary to the meaning thereof be deemed to mean and include its successors in business and permitted assigns/ partners for the time being and the survivor or survivors of them) of the other part.

NOW THEREFORE, IT IS AGREED AS FOLLOWS BETWEEN THE PARTIES HERETO:

WHEREAS

The **Hospital** is a well-known super-specialty hospital located in Gurugram and has agreed to extend its medical facilities to the residents of "SLERWA" and for that purpose both the parties have agreed to enter into this contract on the following terms.

1. TERMS AND CONDITIONS

- a) The Hospital will provide medical facilities to the employees of the Company and their dependents as per Annexure- I. Personnel assistance will be provided during the same.
- b) The said residents should bring Personal ID cards and/or a referral letter duly signed by the authorized signatory/HR Department of the Company.

2. PAYMENT TERMS

All the payment will be settled by the residents of **SLERWA** and their dependents directly with the **Hospital** at the time of billing. Discount will be as per Annexure-I. No credit billing is agreed between the parties.

3. TERM AND TERMINATION

The term period of the contract will be a period of one year effective from **01st December 2025**. unless either party terminates this contract by providing the other party with 30 days' written notice without assigning any reason. The contract shall be renewed with the mutual consent of both the parties in writing.

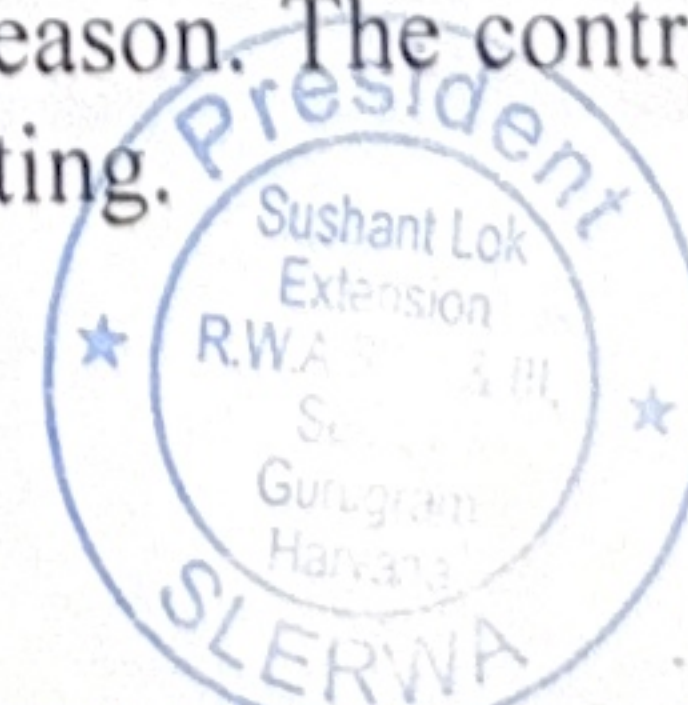

4. GENERAL TERMS

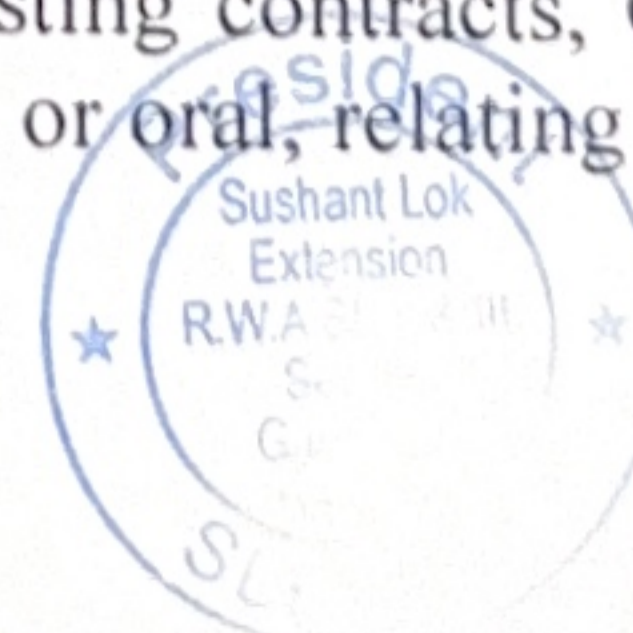
- **Governing Law, Venue, and Arbitration:** This contract shall be governed by the laws of the Republic of India and has been executed in counterpart copies. Any dispute between the parties will be settled amicably through discussions failing which it shall be referred to binding arbitration before a single arbitrator as per Arbitration & Conciliation Act 1996. The forum for litigation or arbitration will be in Gurugram and the parties consent to the jurisdiction of the courts located therein.
- **Notices:** All notices, request, demands or other communications required to be given by either Party to the other shall be deemed to have been duly given or made if sent by e-mail (transmission thereof acknowledged) or by registered post addressed to their respective address mentioned hereinabove. Any change in address shall be notified in writing by such Party to the other within 7 (Seven) days of the event.
- **Confidentiality:** Information furnished or disclosed by one party (the "Disclosing Party") to the other party (the "Receiving Party") in connection with or in contemplation of this Contract, including but not limited to proposals, pricing information, research, computer programmes, software and documentation, transmission plans, facilities deployment information, intellectual property and related technical or business information, shall be deemed "Confidential Information" provided, that, if in written, graphic or other tangible form, the information may also be, but need not be, indicated by appropriate markings or statements to be confidential or proprietor. Such Confidential Information shall be deemed to be the property of the Disclosing Party and shall be returned to the Disclosing Party upon request. Information that was previously known to the Receiving Party free of any obligation to keep it confidential as proven by its written records, or is independently developed by the Receiving Party, shall not be deemed Confidential Information. The Receiving Party shall ensure and provide proper and secure storage for all Confidential Information. All the right, title and interest in and to the Confidential Information (whether acquired or proprietary) shall remain the exclusive property of the Disclosing Party. No interest, license or any right including intellectual in respect of the Confidential Information, other than as expressly set out herein, is hereby granted and/or deemed to be granted to the Receiving Party, by implication or otherwise.
- **Relationship:** The Contract is solely for providing services by Hospital to RWA and Further this Contract does not create an employer-employee, master servant relationship or of a like nature between **Company** and **Hospital**.
- **Waiver:** The failure of either party to enforce at any time any provision of these terms and conditions shall not be considered to be a waiver of such provision or the right thereafter to enforce each and every provision. No waiver by either party, either express or implied, of any breach of any of these terms and conditions shall be construed as a waiver of any other breach of such term or condition.
- **Supersession:** This Contract constitutes the entire understanding between the Parties and cancels and supersedes any and all existing contracts, Contracts and understandings between the Parties, whether written or oral, relating to the subject matter hereof.


- **Assignment:** Neither party shall assign or sub-contract any part of its obligations under this Contract without the prior written approval of other party.



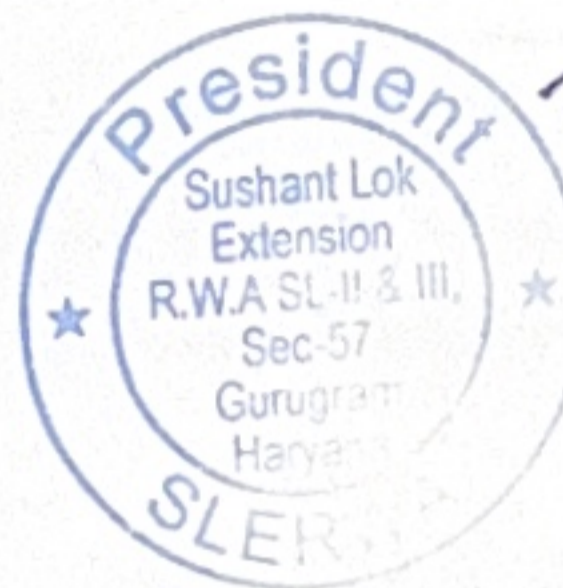
